Official Rules | Good Grades Pay Scholarship Sweepstakes

These are the Official Rules for the 2025-2026 "Good Grades Pay" scholarship sweepstakes (the "Sweepstakes") sponsored by Valley Bank, Division of Glacier Bank ("Sponsor"). By entering the scholarship sweepstakes, entrants and/or their parent or legal guardian agree to be bound by these Official Rules.

Eligibility. There is no charge, fee, purchase, or other consideration required to enter and qualify for the scholarship sweepstakes. Qualified entrants are limited to middle school, junior high, high school, and college students (age 14-25) in Montana ("Eligible School"). The scholarship sweepstakes is void where prohibited or restricted by law. Must be enrolled in public, private, homeschool, or chartered schools.

How to Enter. To enter the scholarship sweepstakes, an entrant must visit any Valley Bank Branch and provide a Valley Bank representative with the student's name, grade, phone number, school name and city (if the entrant is under the age of 18 a parent or legal guardian must provide this information to the Valley Bank representative) to be considered for the scholarship sweepstakes. Employees of Valley Bank and its parent and affiliates, members of such employees' immediate families and individuals living in the same household with such employees, are not eligible to win the scholarship sweepstakes.

Branch Scholarship and Drawing Schedule. In May 2026, a random drawing will be held for 8 different Valley Bank branches for \$500 scholarship. The scholarship of \$500 will be provided via Cashier's Check made out to the qualifying student. To qualify for the \$500 scholarship, the student must be attending an Eligible School as of September 1, 2025.

Notification and Redemption of Scholarship. Each winning entrant of the scholarships will be notified via phone by a First Community Bank Branch manager within one month of the drawing. An entrant is only the winner after he or she has been notified by the Sponsor and he or she has complied with the terms of these Official Rules. Scholarships must be claimed by June 30, 2025, otherwise, the winner forfeits winnings.

Press Releases/Social Media Posts. Sponsor may issue press releases/social media posts containing the winner's name and photo/video, and announcing the winner's Scholarship, with the consent of the winner and the winner's parents (if the winner is a minor). Sponsor will not otherwise release winners' names to the public.

Taxes. All applicable taxes, including any federal, state, or local tax liabilities, are the sole responsibility of the winner(s) and the winner(s) may receive an IRS tax reporting statement for the approximate retail value of the scholarship. If tax documentation including a valid W-9 is not completed, the scholarship may be forfeited. Winner will receive a 1099 form upon receiving scholarship.

Odds of Winning. Odds of winning depend on the number of eligible entries received. The winners of the scholarships will be drawn from the pool of eligible entries submitted.

Interpretation. Application and interpretation of these Official Rules, and administration of the scholarship sweepstakes, shall be in the sole discretion of Sponsor. Any decision by Sponsor regarding the scholarship sweepstakes, including determination of the winners, eligibility of the winners, and the amount of the scholarship, shall be final and binding. These Official Rules, and any disputes arising from these Official Rules or the Drawing, shall be interpreted by and governed in accordance with the laws of the State of Montana.

Right to Cancel or Modify Contest. The Sponsor reserves the right to cancel or modify the scholarship sweepstakes at any time if fraud or technical failures destroy the integrity of the scholarship sweepstakes as determined by the Sponsor in its sole and absolute discretion, and to cancel or modify the scholarship sweepstakes prospectively (i.e. Without terminating any current entrant's participation in a scheduled upcoming scholarship sweepstakes) for any reason.

Release and Limitation of Liability. Neither the Sponsor, nor its parent or affiliates, nor their respective agents, officers, directors, employees, agencies, or attorneys, are responsible for, and contestants release all such parties from any liability arising from, (a) any damages, loss or liability with respect to use of the scholarship awarded in the scholarship sweepstakes, (b) incomplete, lost, late, damaged, illegible or misdirected entry forms, (c) hardware or software failures of any kind; (d) lost or unavailable network connections; or (e) failed, incomplete, garbled or delayed computer transmissions, whether any of the foregoing are caused by users or by any of the equipment or programming associated with or utilized in the scholarship sweepstakes, or by any technical or human error which may occur in the processing of submissions, which may limit a contestant's opportunity to participate in the scholarship sweepstakes.
